

THE SMALIN JENITA / CHRISTY DANIUS CASE

Chronological Order of Events as per Christy

27th July 2007 - Last day in Infosys since I got a new job in Greenville.

31st July 2007 – Morning I traveled to Greenville around 5 am in the morning. At 2.40 p.m I met an accident in I 77S near Yadkin County. All my family members where taken to hospital.

I immediately informed my friend to call my Indian relatives & inform the accident since I have no idea of any phone number in India as my cell phone was totally smashed in that accident.

In the hospital I signed certain papers for operation for my Sister and Smalin. By the time doctors were performing operation on my fathers hand to stop the blood.

1st August 2007 – I received call from my in-laws & I explained about the accident and said that 2 persons condition is very serious .I couldn't talk to anyone for a long time since I am disturbed in a great way & I was breaking off, as I saw the whole incident & my loved ones in blood.

2nd August 2007- one friend of mine came to Hospital & bought me a cell phone & he was beside me for a long time. On the same day Smalin had a C2 fracture and I was in the waiting room till the operation end.

3rd August 2007 – For my sister, doctors told that they are going to open the skull to remove the excess fluid from the cranial chamber. Operation was fixed in the evening but she came out of the coma in the afternoon hours. On the same day my mother was discharged from the hospital.

18th Aug 2007 – Leema was discharged from the hospital and I was in the waiting room for Smalin's Tracheotomy operation till the end.

19th August 2007 – Leema is readmitted in the emergency ward of the hospital again.

20th August 2007 – Leema was discharged from the hospital again.

27th August 2007 – My father was discharged from the hospital.

Till **1st week of Sep. 2007**, Smalin relatives where regularly updated on her medical condition. During this time, I used to visit Smalin regularly and followed all the instructions from the hospital staff to get her to recover as soon as possible.

- When Smalin was in coma, I used to talk to her for hours to remind her of various incidents in our life. I was told that this would help her recover faster.

Case Highlights

27th Jul – Christy's last day at Infosys. He has accepted an offer from another company in a different city and is scheduled to join on Aug 1st.

31st Jul – While enroute to the city of his new job. Christy and his family meet with an accident. [Accident Report from Police attached. Annexure 1]. Christy's wife Smalin and his sister Leema sustain serious injuries and are in coma. [Part of Leema's medical records attached. Annexure 2]. Christy's father and mother also suffer injuries.

3rd Aug – Leema comes out of Coma. Christy's mother is discharged from the hospital.

27th Aug – Christy's father discharged from the hospital.

Sep – Christy finds himself jobless, without health insurance and mounting medical bills of \$350,000.

- I used to keep a mp3 player with melodious songs that she likes and I make it a point that it is played all the time
- As per Osteology doctors instructions I used to remove the gloves on her right hand and used to give some stretching exercises for the palm and fingers and also used to position the foot pad pertaining to traction unit to heal the fractures on her leg in faster track
- I used to look into the traction per the instruction of doctors since when the shift changes for the nurses some might not align the legs properly
- Since one of the nurses made a mistake in the traction and that has caused the left leg of Smalin with bruises caused due to the thrust caused by a bolt and that has left a wound on her left Tibia region on her leg. Due to this I once complained the nurse for negligence
- Also she had involuntary action due to that they tied her leg to the bed with some nylon belt and that caused a bruise on her ankles and I asked them to adopt some other method and hence they stuffed her leg with pillows so that the cushion would soothe her
- When Smalin was in coma, I used to clean the sweat from her face.
- I used to massage her foot using the technique I learnt from Yoga

In September, I was told by my new company (that I had not been able to join because of the serious condition of my wife Smalin and other family members) that they need someone who can concentrate on the project and given my family conditions, I should spend my time taking care of my family. Essentially, they withdrew the job offer.

I was without a job and hence medical insurance. The coverage provided by the auto insurance policy has already run out and the costs for the treatment were mounting. Later hospital pressurized me to discharge Smalin & take her to Home or shift her to Chennai. So I informed Justin Raj (Smalin's brother) through Telephone that I need to talk in person to Sebastian & inform him, the need to shift her to India & the treatment to be taken after that period. Even I insisted Justin till 12th Sep 2007 that I need to talk to his father.

Even though I was traumatized by the accident and its aftermath and was hardly in a position to work, financial conditions forced me to look for a new job. I began a job search in earnest to take care of my family.

17th Sep & 18th Sep 2007 – Due to job interviews in Charlotte (3 hours away from the hospital) and other related problems, I could not visit the hospital, like I usually did.

Case Highlights (contd.)

23rd Sep – Sebastian (Smalin's father) comes to US after filing a police complaint against Christy and his family for torturing Smalin for dowry. Reports appear in local newspapers where Sebastian alleges "For the reason that Dowry was not given, I am suspecting that my daughter was made a part of this accident." [Tamil Newspaper Report and it's rough translation attached. Annexure 3]

30th Sep – Smalin's relatives ransack Christy's grandparent's house and Christy is told to hand over Legal Guardianship to Sebastian.

4th Oct – Sebastian takes over Legal Guardianship of Smalin

14th Nov – Smalin is shifted to India

21st Nov – The story is broken to the media in a big way. It is claimed that Smalin sustained her injuries because she was thrown out of a moving car [IBN Live 21st Nov, 2007. Annexure 4]

20th September 2007 – With the medical bills climbing to \$350,000 and having run out of insurance coverage and all other options, I told the Patient relationship director that I do not have the means to pay the medical bill nor do I have the financial capacity to shift Jenita to India.

On that day they asked permission from me, whether they can permit Sebastian to see his daughter. I approved the same and said that there is no issue.

23rd September 2007 – Sebastian came & saw his daughter in Hospital from 2.15 PM to 2.25 pm. This was informed to me when I entered Jenita room around 2.30 p.m along with my sister.
(visiting hrs for acute care in the afternoon hrs is 2 to 3.30 PM).

24th September 2007 – Through a local newspaper in India, I came to know that he came to USA after giving a complaint to Trichy Police station that we pushed his daughter out of car for dowry sum. I was shocked to see the photos of Smalin taken in Hospital without my permission.

So around afternoon I went to Amanda (Patient relationship director) and gave her the news clipping along with the photo & asked her who did it. She said that she would investigate the matter.

After that I used to receive calls from India, where by the other side would threaten me stating whether I am planning to kill Smalin with the help of hospital. This kind of call continued till 3rd Oct.2007.

30th Sep. 2007 - Sebastian family members entered into my house along with Goondas & looted my house things in Trichy plus they have beaten my grandfather & forced him to enter an auto in knife-edge & made him to board a bus. They also said to him that I am trying to kill his sister & that's the reason I am not accepting change of guardianship to Sebastian

1st Oct 2007 – I received a call from India with indecent words and things which cannot be revealed .So finally I said enough.

2nd Oct 2007 – I informed Amanda to go ahead with the guardianship change in favor of Sebastian. I also informed that I would never turn up to the court since I don't want to see the face of Sebastian.

Till **Oct 5th 2007** I received calls from India in late hrs, e.g. 1 am or 3 am .So after that I will switch off my cell in the nights hrs & switch back in early morning hrs alone.

In Oct middle I was informed that Smalin was out of Coma & Amanda later confirmed it. But Amanda told that since the guardian has changed, I need to get permission from Sebastian to see his daughter. I said that's ok.

Nov. 10th 2007 - I was informed that Smalin is going to be shifted to India on **14th Nov. 2007**. Later the same was confirmed by GEICO claim manager since GEICO has released a sum to Smalin & I was informed by the claim manager that hospital accepted Sebastian to take that amount.

Once she landed in India, from day one they are repeating the same story said by them from 23rd Sep. 2007 to local newspaper.

Case Highlights (contd.)

19th Dec – A case of torture and dowry harassment is filed against Christy and his Family. [Newindpress.com 19th Dec, 2007. Annexure 5]

22nd Dec – NCW takes up Samlin's case saying that the case would be referred to Ministry of External Affairs and "top priority would be accorded to her case to prosecute them (Christy and his family)" [The Hindu, 22nd Dec, 2007, Annexure 6]

Injuries Suffered by my Family in the Accident

1. My sister was in coma for a few days and had severe head injury including injury to her brain. She had multiple fractures on various parts of her body. The extent of her injuries can be gauged by her medical reports [Annexure 2]
2. My father was also having a serious injury, till date his left hand is completely paralyzed. He had C4 fracture & fracture on his nasal bridge. Due to the compression caused in the spinal cord his nervous system got affected and his left side part of the body was paralyzed. Now he can walk slowly but his left hand is still paralyzed.
3. Mother got a spinal cord injury & the spinal sprain is still uncured.

Layman's explanation of Leema's injuries as per the medical reports obtained (Annexure 2)

Page 1

Leema Pillai had an endotracheal tube in place and was on a ventilator when she arrived at the level II trauma center. This would suggest that the medical staff had concerns about her being able to breathe properly on her own (or possibility of compromised airway). She had a deep cut to the back of her head that had been sutured. She was admitted to the Intensive Care Unit with the diagnosis of fractures of the skull, thoracic and lumbar spine, and left hip. The medical staff was also concerned about the likelihood of brain injury. A brain scan was ordered along with a Neurosurgical and Orthopedic consult.

Page 2

The brain scan showed that Leema Pillai there was bleeding around the brain (under the skull fracture). The abdominal scan showed that there had been bleeding in the left side of the pelvis (along with the hip fracture) that was compressing the urinary bladder. Urine exam showed blood in the urine. X-rays of the vertebral bodies showed - multiple bony fractures of different parts of the spine. The lungs were either collapsed or bruised.

Thought provoking Questions

1. The claim is that Smalin "was made a part of this accident" because sufficient dowry was not given. This seems to suggest that the accident was staged. Why would someone stage an accident where his own sister is injured so seriously that she is in coma and suffers skull fracture and brain damage and his parents suffer serious injuries as well?
2. If Christy's family was indeed pushing Smalin out of the car, why was a case not registered against Christy and his family in the USA?

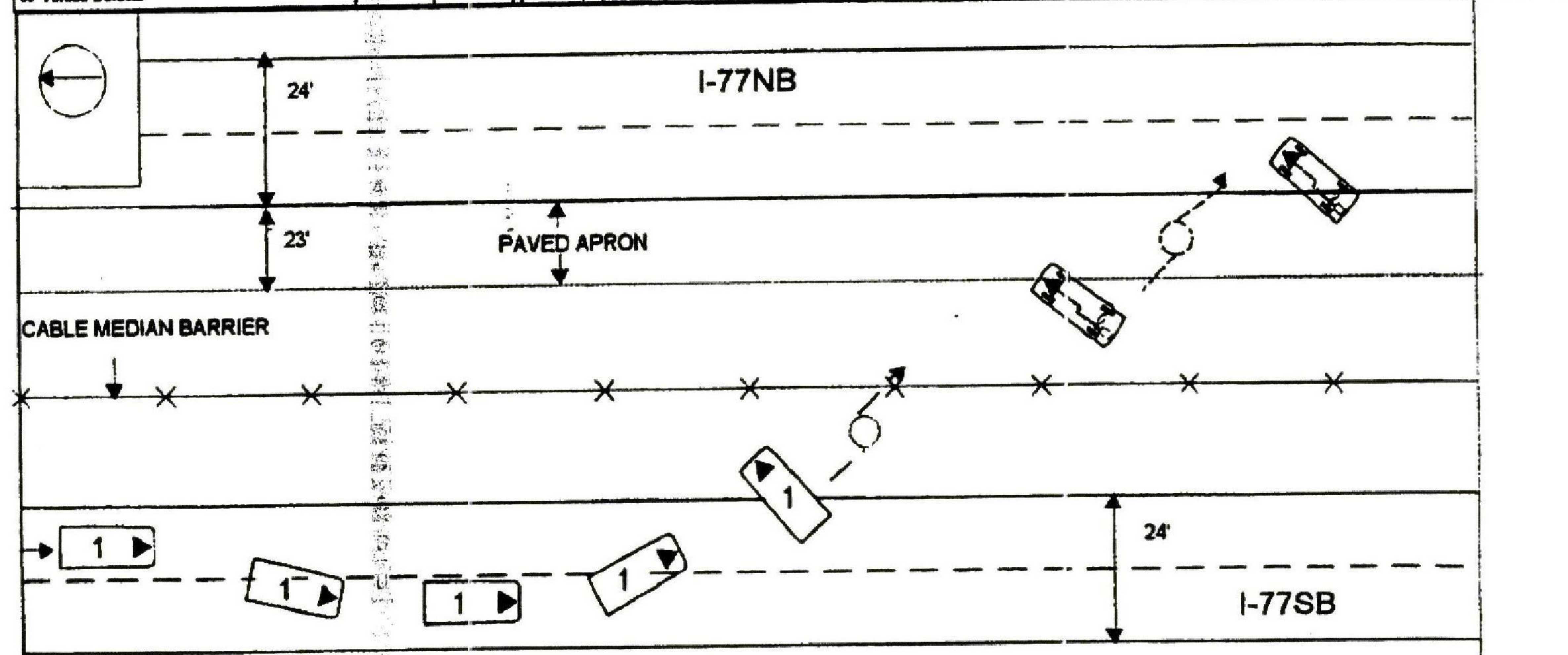

திருச்சி பாலக்கரையைச் சேர்ந்தவர் செபாஸ்டியன். தனியார் கம்பெனி மேலாளர். மகள் ஸ்மாலின் ஜெனிட்டா (23). எம்.பி.ஏ. மாணவி. இவருக்கும் காட்டூர் ஸ்ரீராம் நகரில் வசித்து வந்த சேவியர் மகன் கிறிஸ்டி டேனியல் என்பவருக்கும் கடந்த ஆண்டு திருமணம் நடந்தது. கம்ப்யூட்டர் இன்ஜினியரான கிறிஸ்டி டேனியல் அமெரிக்காவில் இன்போசிஸ் கம்பெனியில் வேலைபார்த்து வந்தார். தனது தாய், தந்தை மனைவி ஆகியோரையும் அமெரிக்காவுக்கு அழைத்துச் சென்றார். தற்போது ஸ்மாலின் ஜெனிட்டா 5 மாத கர்ப்பினியாக உள்ளார். இந்நிலையில் கடந்த ஆகஸ்ட் 31 ம் தேதி அன்று கிறிஸ்டி டேனியல் குடும்பத்தினர் சென்ற கார் அமெரிக்காவில் விபத்துக்குள்ளானது. கர்ப்பினியான ஸ்மாலின் ஜெனிட்டா சாலையில் தூக்கி எறியப்பட்டார். இதில் அவருக்கு கழுத்து எலும்புகள் உடைந்தன. அவரையும், அவருடன் சென்ற குடும்பத்தினர் 4 பேரையும் அமெரிக்க போலீசார் ஹெலிகாப்டர் மூலம் மீட்டு ஆஸ்பத்திரியில் சேர்த்தனர். ஸ்மாலின் ஜெனிட்டா தற்போது கோமா நிலைக்கு சென்றுள்ளார். ஆனால் டேனியல் இதுபற்றிய எந்த விபரத்தையும் திருச்சியிலுள்ள ஸ்மாலின் ஜெனிட்டாவின் பெற்றோருக்கு தெரியப்படுத்தவில்லை. அமெரிக்காவில் உள்ள குடும்ப நண்பர் ஒருவர் மூலமாக இதனை அறிந்த செபாஸ்டியன், அங்குள்ள மற்ற நண்பர்களை தொடர்பு கொண்டு விபத்து குறித்து விசாரித்தார். அப்போது விபத்து நடந்த சாலையில் குறைந்தபட்சம் 100 கி.மீ வேகத்துக்கு குறையாமல் செல்ல வேண்டும் எனவும், அந்த சாலையில் யாரும் திடீரென பிரேக் போடக்கூடாதெனவும் போலீஸ் கட்டுப்பாடு உள்ளதாகவும், அதனை மீறி இந்த விபத்து நடந்ததாகவும் தெரியவந்தது.

இதையடுத்து தனது மகள் வரதட்சணை கொடுமை காரணமாகவே விபத்தில் சிக்க வைக்கப்பட்டிருக்கலாம் எனக்கருதி திருச்சி கோட்டை அனைத்து மகளிர் போலீசில் செபாஸ்டியன் புகார் அளித்துள்ளார். அதில் அவர், “ திருமணம் நிச்சயிக்கப்பட்டபோது வரதட்சணையாக 75 பவுன் நகை மற்றும் சீர்வரிசை சாமான்களுக்கு பதிலாக ரூ.1 லட்சம் பணம் தர வேண்டும் எனக் கேட்டிருந்தனர். நாங்கள் பெண்ணிற்கு 50 பவுனும், மாப்பிள்ளைக்கு 10 பவுனும் போடுவதாக தெரிவித்தோம். அதற்கு அவர்கள் ஒப்புக்கொண்டனர். திருமண ஏற்பாடுகள் முடிந்தநிலையில் தாங்கள் கேட்ட நகையும், பணமும் தர வேண்டும் என மீண்டும் டேனியல் குடும்பத்தினர் கூறினர். பிறகு தருவதாக கூறி எங்கள் செலவில் திருமணத்தை திருச்சியில் நடத்தினோம்.

Due to dowry not given Tragedy and in America Trichy lady in Coma

Trichy, September 23.

Due to dowry not given, an accident was created and her daughter was pushed to Coma, was the complaint filed on Groom in America by a father of a lady in Trichy Police Station.

Sebastian is from Palakkarai Trichy. He is a private company officer. His daughter Smalin Jenita (23) is a MBA student. She was married to Xavier's Son Christy Daniel who hails from Kattur's Sriram nagar last year. Christy Daniel, who is a computer engineer, was working in Infosys Company in America. Christy Daniel took his Mother, father and Wife to America. At that time Smalin Jenita was 5 months pregnant. At this stage on August 31st, the car in which Christy Daniel's family was traveling encountered in an accident. Pregnant Smalin Jenita was thrown away in the road. Due to this, her neck bones were broken. Smalin Jenita, and the 4 family members traveling were rescued and lifted in helicopter by American Police, and admitted into hospital. Smalin Jenita went into coma at this time. But, any detail about this was not shown by Daniel to Jenita's parents who were in Trichy. Sebastian came to know about this through a family friend in America, and contacted other friends here and enquired about the accident. He came to know that the road in which accident happened was bound by Police rules that, at a minimum 100KM speed needs to be maintained on the lower end and in that road no one can apply brakes suddenly, and beyond this the accident had happened.

After this, Sebastian has filed a complaint in Trichy Kottai All Women's Police Station, concluding that his daughter should have been tangled into this accident for the reason of Dowry torture (Harassment). In this, he also says, "At the time of finalizing the marriage, a Dowry of 75 Pavun Jewels and instead of articles, Rs 1 Lakh was asked by them. We said, we will do 50 Pavun for girl and 10 Pavun for Groom. They agreed to this. At the stage when the marriage efforts were completed, Daniel's family members said we need to give the jewels and money asked again. After this we also said that we will give this and conducted the marriage at our expense in Trichy. He did not behave with affection with my daughter. At this stage everyone started and left to America. After some days, from America, Smalin Jenita sent me an email. In this she has mentioned that her husband, Mother In Law, and Father In Law all 3 of them were jointly torturing/harassing her to acquire and give the balance of the Dowry. When we are in the middle of making efforts for preparing for this amount this accident has happened. For the reason that Dowry was not given, I am suspecting that my daughter was made a part of this accident. As such he has mentioned in this petition. Police have given a petition receipt for this. Following this, he, to see his daughter, is involved in making efforts to go to America. Regarding this incident, he has made a petition request to Tamil Nadu higher police officials to contact Police in America to conduct appropriate investigation. Regarding this complaint, to get an opinion, he made many attempts to contact Christy Daniel's family members, but he was unable to establish a contact.

Pak doctor plays saviour to Indian dowry victim

New Delhi: Twenty-three-year-old Samlin Jenita lies in Chennai's Mehta Hospital battling for life. Twenty-eight weeks pregnant, seriously bruised and nursing a severe brain injury, Jenita is a victim of dowry harassment.

She was flown to Chennai from the US on Sunday night in a special air ambulance after her family got a frantic call informing them of her accident and urging them to take her back.

Jenita was allegedly beaten up by her husband Christy Danius - an Infosys employee in the US - who reportedly threw her out of a moving car.

She was rescued by Sardar Inamullah, a Pakistan-origin pathologist, and sent home.

"Jenita was brought into our hospital on July 31 and she was severely injured. She sustained 80 per cent burs and there seemed to be no chances of survival," Inamullah told CNN-IBN.

However, Danius denies the allegations and says Jenita was injured in a car accident in which he and his sister and parents were hurt as well. He claims that he had provided her contact numbers and address in India to the hospital as well.

But Samlin's parents say they got to know only when they got a call from Inamullah who got suspicious while treating her.

Inamullah is a pathologist at the Lake Forest Hospital in Illinois and was the first to suspect something was wrong when a badly-hurt Jenita was rushed into the hospital by a police patrol van. She was brought to the hospital in a state of coma, with multiple bone fractures.

"Initially, I started helping the family but I realised there was something wrong. There was no information, no insurance papers, nothing. Then I heard her husband had left her and abandoned in the hospital. The state of North Carolina wanted to take her custody," said Inamullah.

He says none of Jenita's relatives came to see her while she was battling for life. "Her husband came for first few weeks but none of her relatives came. Then he disappeared too. That's when I and some of my Indian friends - including Mr Sebastian - got her custody," he said.

Inamullah says Jenita also narrated her version of the story. "She told us there was a fight inside the car and they were trying to push her out. That's when her husband - who was at the wheel - lost control."

As of now, both Jenita and her child are in a stable condition in Chennai's Mehta Hospital. But Jenita has been paralysed on the left side due to the brain injuries.

TIRUCHIRAPPALLI : An all woman police station here registered a case of torture and dowry harassment against U.S. Based in laws of Samlin Jenita, hailing from here, a month after she was flown back home for treatment.

NCW takes up the case of 'tortured' Tiruchi woman

Tiruchirappalli (PTI): An official of the National Commission for Women on Saturday described the "torture and harassment" meted out to Tiruchi-based Samlin Jenita by her NRI husband and in-laws in the US as 'shocking' and decided to refer her case to the External Affairs Ministry for action. Commission member Nirmala Venkatesh, after meeting Jenita, told reporters here that she was shocked by the way she was allegedly treated by her husband, mother-in-law and sister-in-law in Illinois to bring more dowry and top priority would be accorded to her case to prosecute them.

The NCW, which took suo motu notice of this incident based on press reports, would take steps to summon husband Christy Danius (31) to India to take action against him, she said.

Jenita returned home from Illinois with multiple injuries after a Pakistani national working in a hospital where she was undergoing treatment in US alerted her parents here. An all-woman police station here had registered a case of murder and dowry harassment against Danius, mother-in-law Chellam and sister-in-law Leema, a month after she was flown back home for treatment.

Her father Sabastin Anthony, a retired employee of Bharat Heavy Electrical had filed a complaint with the DGP. But the case was registered only on December 19 due to wrangle over jurisdiction between the rural and city police here. Finally it was decided that rural Police would register the case. Her father alleged she had suffered mental and physical torture as a result of the harassment and that she was pushed out of a speeding car.

Venkatesh who arrived here from Delhi said Jenita narrated to her how she was reportedly pushed from the car, besides other incidents and she recorded Jenita's testimony. She said, if needed, she will meet Chief Minister M Karunanidhi.
